## 2. Hazards Identification

**Emergency overview** CONTENTS UNDER PRESSURE. Aerosol. Pressurized container may explode when exposed to heat or flame. Prolonged exposure may cause chronic effects. May be ignited by heat, sparks or flames.

**Potential health effects**

**Routes of exposure** Ingestion. Skin contact.

**Eyes** Health injuries are not known or expected under normal use.

**Skin** This product may be harmful if it is absorbed through the skin. Prolonged or repeated contact can result in defatting and drying of the skin which may result in skin irritation and dermatitis (rash).

**Inhalation** Intentional misuse by concentrating and inhaling the product can be harmful or fatal.

**Ingestion** Exposure by ingestion of an aerosol is unlikely. Components of the product may be absorbed into the body by ingestion.

**Target organs** 2-Butoxy ethanol may be absorbed through the skin in toxic amounts if contact is repeated and prolonged and may cause blood damage. These effects have not been observed in humans.

## 4. First Aid Measures

**First aid procedures**

**Eye contact** Immediately flush eyes with plenty of water for at least 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Get medical attention if irritation develops or persists.

**Skin contact** Immediately take off all contaminated clothing. Wash off with warm water and soap. Get medical attention if irritation develops or persists.

**Inhalation** If symptoms develop move victim to fresh air. If symptoms persist, get medical attention.

**Ingestion** Rinse mouth. If ingestion of a large amount does occur, call a poison control center immediately.

<b>Suitable extinguishing media</b>	Water fog. Foam. Dry chemical powder. Carbon dioxide (CO <sub>2</sub> ).

<b>Protective equipment and precautions for firefighters</b>	Containers should be cooled with water to prevent vapor pressure build up.

## 6. Accidental Release Measures

<b>Methods for containment</b>	Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Stop leak if you can do so without risk. Move the cylinder to a safe and open area if the leak is irreparable. Stop the flow of material, if this is without risk. Prevent entry into waterways, sewers, basements or confined areas.
<b>Methods for cleaning up</b>	Should not be released into the environment. Use a non-combustible material like vermiculite, sand or earth to soak up the product and place into a container for later disposal.  Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean contaminated surface thoroughly.

## 7. Handling and Storage

<b>Handling</b>	Pressurized container: Do not pierce or burn, even after use. Do not handle or store near an open flame, heat or other sources of ignition. Use only in area provided with appropriate exhaust ventilation. Do not use if spray button is missing or defective. Do not get this material in contact with eyes. Do not get this material in contact with skin. Avoid prolonged exposure.
<b>Storage</b>	Level 1 Aerosol. Contents under pressure. Do not puncture, incinerate or crush. Keep away from heat, sparks, and flame. Do not expose to heat or store at temperatures above 120°F/49°C as can may burst. Avoid exposure to long periods of sunlight. Keep out of the reach of children. Do not store, incinerate, or heat this material above 120 degrees Fahrenheit.
